TERMS & CONDITIONS

1. All deposits and payments are non-refundable, in the event of a date change or cancellation for any reason.
2. The cost & a signed copy of this contract must be received before any photographs will be processed.
3. The Client & the Photographer agree to the price & items listed within the Package chosen by the Client & listed on the first page of this contract. Both parties will honor those details through the money, items & services exchanged.
4. An online gallery and/or disc of images, if included in session/package, will be available 2-5 weeks from date of session/event.
5. If Christa Holland is unable to perform to the guidelines of this contract due to a fire or casualty, act of God, act of terrorism or other cause beyond the control of the parties, Christa Holland shall have no further liability with respect to the agreement. If Christa Holland is unable to perform to the obligations in the contract for any other reason, Chris Holland will not be liable for costs in excess of the amount the client has paid. This limitation of liability will also apply in the event that the high resolution digital files are lost through camera malfunction, damaged in processing, lost in the mail, or otherwise damaged or lost with or without the fault of the photographer Christa Holland. While every attempt is made to create the best images possible, no particular photo is guaranteed.
6. In the event of Christa Holland's illness, other unforeseen circumstance or scheduling conflict, the photographer Christa Holland may substitute another competent photographer to take the photographs. In this event, either the photographer, or substitute, will contact you.
7. Images maybe used for personal use only, and may not be sold or published without the written consent of Christa Holland. Photos may not be posted online for sale on commercial photo lab websites such as, but not limited to, Shutterfly.com and Snapfish.com. However, they maybe posted on community sites such as facebook or myspace only if the proper credit is attributed to Christa Holland. If a disc is included in a package or purchased from the photographer, watermarked files will be included the provide the proper credit. 8. All rights to the images created by Christa Holland will remain with the photographer. Christa Holland reserves the right to display any photographs made in conjunction with this session as samples of her work for the purpose of window and showroom exhibits, stock photography, editorial, advertising, promotion on the internet, publication, instruction and professional competition. If the client does not wish to allow this, they must provide a viable reason and the \$35.00 model form discount will be voided.

9. The Client understands that due to the inherent qualities of photographic dyes and materials, the photographs may fade or discolor over time. The Client agrees to release the photographer, Christa Holland, from any liability for any claims based whatsoever upon fading or discoloration due to such inherent qualities.

10. If photographs are requested that are taken in low-light environments that prohibit the use of flash, the Client understands that high ISO settings must be used, possibly creating pixilated, noisy, or grainy effects in the photographs.

11. Traveling beyond a 60 minute radius of the photographer's home will incur travel fees, based on mileage or travel via airline, food and lodging and/or other fees if necessary, such as toll roads.

12. Any changes to this Agreement must be in writing and signed by both parties. The Agreement incorporates the entire understanding of the parties and is governed by the laws of the State of Texas. By signing this contract, the photographer and the client agree to all terms & conditions stated in this contract.
